Cruise rate is based on a minimum of 15 paid persons. An onboard “Rock the Boat” representative is required by Carnival Cruise Lines; therefore, groups with less than 30 paid persons will be charged an additional fee of \$50.00 per person for onboard escort fees.

Cruise rates are per person, based on Category 4A and does not include transportation. Space is limited on each sailing; please contact our office for additional information regarding availability.

All taxes, fees (includes International Departure Tax and U.S. Customs Fees), and prepaid gratuities are included in your cruise package cost. These items are subject to increase by the Port Authority and cruise line and will be the only variable cost in your package.

Security Deposits are not required for performing groups. A security deposit of \$50.00 per student is required for non-performing groups. Should any violation of the ship rules occur or if your group fails to attend the orientation meeting, Rock the Boat with Festivals at Sea has the right to retain all or part of the total security deposit amount of the entire group. Security deposits will be returned within 4 weeks after the cruise providing the guidelines of your student conduct agreements have been met.

Complimentary cruise berths must be used by Parent Chaperones or School Affiliated Chaperones Only. These berths are based on double occupancy and include all taxes, fees and prepaid gratuities. Although you are not required to have a chaperone in each cabin, each group must have one chaperone (over age 25) for each ten students.

TRANSPORTATION

ROUNDTrip AIRFARE

May be provided based on the lowest published rates at time of booking. Availability and price will vary depending on your group size, specific dates and times of departure. Rates will be considered firm once you have received a contract and providing your deposit is received in our office in accordance with the due date in the contract. All airline deposits and payments are 100% Non-Refundable upon receipt into our office.

Airport Transfers to and from the port of departure may be provided at the following Per Person rates: Miami \$35.00 pp, Ft. Lauderdale \$40.00 pp, Port Canaveral \$50.00 pp, Jacksonville \$35.00 pp, Tampa \$40.00 pp, Mobile \$40.00 pp, New Orleans \$50.00 pp, Galveston \$70.00 pp and Long Beach \$50.00 pp.

All Airport Transfer fees are based on a minimum of 30 paid persons and include ONLY the roundtrip transportation to and from the port. Extra moves will result in additional cost. Cancellations made after 5:00pm (EST) 30 days prior to arrival are 100% Non-Refundable.

CRUISE / TOUR PACKAGE CANCELLATION POLICY

- \$50.00 Fee per person if the entire group cancels by 5:00pm (EST) 120 days prior to arrival. All group deposits are 100% Non-Refundable if the entire group cancels after this date and time.
- \$75.00 Fee per individual cancellation made After 5:00pm (EST) 120 through 90 days prior to arrival.
- \$200.00 Fee per individual cancellation made After 5:00pm (EST) 90 through 30 days prior to arrival.
- Cancellations made inside of 30 days prior to arrival are 100% Non-Refundable.

NAME CHANGES

• Rooming List

Once your rooming list has been received, a \$75.00 Fee will be applicable for each and every change involving names. **Important: Legal first and last names must be provided on the original rooming list.**

• Airline Passenger List

A \$75.00 Fee will be applicable for each and every change involving names made after 5:00pm (EST) 45 days prior to departure. If tickets have to be expressed mailed (due to name change) an additional charge of \$15.00 will be assessed. Be advised that due to constant changes in the airline industry this policy is subject to change. Airlines may increase their fees or name changes may not even be permitted without purchasing another ticket.

Written notice of all cancellations and name changes must be received into our office in accordance with the deadline dates listed on your contract. The most current rooming list received by our office will serve as a guideline when individual cancellation fees become applicable. If for any reason a rooming list has not been received, the guideline will revert to the number of reservations originally confirmed on the group confirmation.

PERFORMING GROUPS

Instrumental, vocal, drama and dance groups have the opportunity to perform onboard ship. These performances are organized by “Rock the Boat with Festivals at Sea” and are designed to enhance your cruise experience.

CARNIVAL CRUISE LINES

- * Group size, staging requirements and lounge availability will determine the performance location onboard ship and are dictated by Carnival Cruise Lines.
- * Performance venue, stage sizes and wing space vary by ship.
- * Show length is a maximum of 1 hour.
- * Chairs, sound system, a maximum of three microphones and theatrical light and sound technicians will be available for performances onboard ship. Any additional requirements will be at the group’s expense.
- * Rehearsal time may be requested, however it is based on availability and a sound system technician is not present for your rehearsal. However, a personal CD player may be used for rehearsals.
- * No instruments are provided for performances.
- * Dance groups are not permitted to Tap or Clog.
- * U.S. Customs mandates that all instruments and equipment be registered, before sailing, with your local U.S. Customs Office using the U.S. Customs Form 4455 provided in the Forms section of this booklet.

“FESTIVALS AT SEA” OPPORTUNITIES (\$35.00 PER PERSON)

The nationally acclaimed “Festivals at Sea” program is again available on board ALL the sailings for 2007! Your performing group(s) will have the opportunity to enhance their cruise experience with an Adjudicated Performance and Clinic on board ship. For the low price of \$35.00 Per Person, we will provide a nationally known instrumental, vocal or dance Adjudicator to clinic each group performance while providing written and taped evaluations for ratings based on a national standard. Festivals groups must have a minimum of 50 paid persons. The entire group, including non-performers, must pay this additional charge.

GENERAL CRUISE TRAVEL TIPS

... PASSPORTS REQUIRED FOR ALL CRUISE TRAVELERS ...

TRAVEL DOCUMENTS. Resident Aliens need an Alien Resident Card. Aliens need a valid Passport and valid U.S. Multiple Re-Entry Visa. **IMPORTANT!** If you have anyone in your group that is a foreign exchange student or not a citizen of the United States, they must contact their Local Immigration office to determine what paperwork they will need. Any person not having the necessary travel documents will not be allowed to board the ship and will not receive a refund for their cruise.

All travel documents should be filled out and all luggage & equipment tagged with the provided Carnival Cruise Lines' luggage tags prior to arrival at the port. Each passenger must have in their own possession travel documents including Passport and Carnival Cruise Lines' tickets when checking in at Embarkation. These items must be passed out to each individual prior to arrival at the port.

FUNPASS CHECK-IN. After you receive your cruise documents, it is strongly suggested that you register on-line with Carnival at www.carnival.com/mycruise. In order to register on-line, you will need your Individual Booking Number displayed on your FunPass Status Information page provided in your cruise documents. This advance registration will expedite your check-in process on the day of sailing.

STUDENT CHAPERONE ACKNOWLEDGMENT FORM. Every student or chaperone must complete and return the respective Carnival Cruise Lines Acknowledgment Form. Performing groups are exempt from the statement that guests under the age of 18 years must be accompanied in the same stateroom by an adult 25 years of age or older. We require that the group have at least one chaperone for every ten students.

CHECK-IN. Upon your arrival at the port, you will be met in the baggage area by a "Rock the Boat" representative, who will assist with your check-in.

SAIL & SIGN. No cash is accepted for purchases onboard ship. All passengers must use a Carnival "Sail & Sign" card for all ship purchases. Your "Sail & Sign" account must be set up with a valid credit card, cash, or travelers check. No business or personal checks of any kind will be accepted. The birth date of the cardholder is entered into the master computer on the ship and anyone under the age of 21 will not be permitted to purchase alcohol. Carnival Cruise Lines and your travel company are not responsible if a person under the age of 21 is caught with an alcoholic beverage. This is solely the responsibility of the group's chaperones. A \$100.00 minimum is required to set up a Sail & Sign account.

SPENDING MONEY. You will need money for baggage handling, souvenirs, shore excursions, cab fare in port, and any beverages onboard ship not included with meals. Iced tea, water, milk and coffee/tea are included with meals. Juices are offered at breakfast. Soft drinks onboard ships are approximately \$2.75 per 20 oz. bottle which does not include gratuity. An unlimited Soft Drink Fountain Card can be purchased onboard ship.

GRATUITIES. Your prepaid cruise gratuities cover Dining Room Waiter, Bus Boy, and Cabin Steward. Tips are not included for curbside stevedores, with a \$1.00 per bag/equipment being customary. Tips are not included for room service. \$1.00 per person is customary. Beverage purchases onboard ship include gratuity.

CLOTHING. Casual attire is in order during the day. For one or two nights, formal dress or a dark suit is strongly suggested. A Tuxedo is also appropriate but not required. The dress codes for other evenings range from sport coat and tie to casual resort wear. Shorts, T-shirts and jeans are not permitted in the dining room during dinner.

MAIN DINING ROOM SITTINGS. All student groups are assigned early seating (times vary per ship). Table assignments are pre-assigned by cabin and do not expect entire group to be seated together.

MEDICAL SERVICES. The ships' infirmaries are equipped to treat minor non-emergency matters. A doctor is available to render services at a customary charge. Doctors are independent contractors. Groups are encouraged to bring their own health history/medical forms for each person in the group.

SPECIAL NEEDS. Carnival seeks, to the extent feasible, to accommodate guests with special needs so they are able to enjoy their ships and other facilities. For example, service animals are permitted onboard ship if prior arrangements have been made at time of booking. In situations where a guest with special needs, such as a guest in a wheelchair, would be unable to be comfortably accommodated due to vessel barriers and other criteria, they may find it necessary to ask the guest to bring along a companion to assist or make alternative arrangements.

SPECIAL DIETS. Special diet requirements may be requested at least two weeks prior to sailing. You should discuss the method of preparation of menu items with your waiter or head waiter. There may be limitations in our ability to accommodate special orders. Kosher meals are not available.

CABIN BLOCK. All cabins are blocked as close together as possible at Carnival's discretion. Groups are guaranteed at least Category 4A. Oceanview cabins may be purchased for an additional charge based on availability. Some triple/quad cabins will be accommodated with roll-a-way beds at the discretion of Carnival Cruise Lines.

SHIP RULES. We want your cruise to be a pleasant experience for everyone. The following rules must be enforced. Failure to comply with these guidelines will result in the offender(s) being removed from the ship to make his or her own way home at his/her expense:

1. No noise in cabin areas after 11:00pm
2. No running, congregating or consumption of food and beverage in the hallways
3. Abuse of physical property will not be tolerated
4. No abusive or offensive language
5. No drinking of alcoholic beverages for those under the age of 21
6. Purchase, possession and consumption of illegal drugs will not be tolerated
7. Large radios ("boom boxes") are not permitted onboard. Headphones must be used with radios on deck

EMERGENCY TELEPHONE NUMBERS. 1-877-225-7447. You must know the name of the ship and the sailing date (Date of Departure). Approximate cost is \$25.00 - \$30.00 for the first minute and \$8.00 - \$10.00 for each additional minute. This telephone number should only be used in the event of an emergency. Rates are the same for calling ship to shore. Calling Cards may not be used on board.

SHIP PHOTOS. The ship photographers will be taking candid and posed pictures of the passengers on the ship throughout the cruise. Group photos can be arranged for your group through your cruise escort and the ship's photography department.

LIMITATIONS. No food or beverages of any kind may be brought on ship. This includes bottled water. Fruits & Vegetables from a foreign country are not permitted into the United States.

LUGGAGE. You are allowed one suitcase and one carry-on bag for your trip. Upon arrival at the port, stevedores will take bags directly from the bus/car and deliver them to your cabin. Please be prepared prior to arrival to pay a gratuity of \$1.00 per bag for this service. Also make sure all bags and equipment have Carnival luggage tags and are clearly marked with your cabin number. Carnival luggage tags will be provided for your trip. Please keep your travel documents with you and not in your suitcase. Carnival Cruise Lines is not responsible for lost, stolen or damaged suitcases/bags or equipment.

PERFORMANCE INFORMATION

INSTRUMENT STORAGE/LOADING: U.S. Customs mandates that all instruments and equipment be registered, before sailing, with your local U.S. Customs Office using the U.S. Customs Form 4455.

The U.S. Customs Form 4455 is provided in this booklet.

We recommend that instruments/equipment be stored in the performer's cabin. If additional storage is necessary, a special storage cabin may be provided at an additional cost.

Assistance with instrument and luggage loading at the pier is provided by the stevedores. They are employed by the port authority and they will expect a gratuity. This gratuity is not covered under the pre-paid gratuity in your tour package. Carnival Cruise Lines or Four Seasons Tours is not responsible for lost, stolen, or damaged luggage or instruments loaded by the stevedores or stored in cabin provided.

DATE & TIME: Carnival dictates the date, time and location of all performances. Rock the Boat staff makes every effort to arrange performance times while the ship is at sea.

STAGE: Whenever possible, performances take place in the main lounge, however, location is at the discretion of Carnival Cruise Lines. The stage in the main lounge on the Fantasy, Ecstasy, Fascination, Inspiration, Paradise, Sensation, Elation and Imagination is 35' deep x 50' wide. The Holiday and Celebration stage is 22' deep x 40' wide. All have marley floors and a professional sound & light system.

NO TAP DANCING OR CLOGGING ALLOWED.

PERFORMANCE REQUIREMENTS: Each group is allowed one hour for performance including set up and tear down. Additional performances or extended length will be charged to the group at a rate of \$150.00 per hour or any part of an hour. Performers are not permitted to perform songs that include; verbal profanities, racial, ethnic, or sexual slurs, no drug or drinking related songs. Rehearsal time may be requested, however it is based on availability of performance space. Sound & lighting will not be provided for rehearsal.

LIGHTING AND SOUND EQUIPMENT: Theatrical lighting and sound equipment is provided by Carnival Cruise Lines. Sound equipment is capable of playing compact discs only, and is not capable of playing cassette tapes. A Carnival sound and lighting technician will be provided to assist with your production. Only the technician is permitted to operate the sound and lighting equipment. NOTE: It is suggested that a person from your group sit in the booth with the technician during the performance. This person can introduce your group from the booth or you may designate someone to make the introduction from the stage.

DRESSING FACILITIES: Where possible, uniform and costume changes should be made in the performer's cabin prior to the performance. A backstage manager will be present to supervise activities on stage including changing areas.

PERFORMANCE EQUIPMENT: An acoustic piano or electric keyboard will be available on all ships. Music stands and risers are available on the Fascination only. Music stands only, are available on the Paradise. Chairs can be provided for your performance and must be pre-arranged on your performance information form. No instruments will be provided and music stands or risers are not available on other ships.

FESTIVAL RULES & INFORMATION

INSTRUMENT STORAGE/LOADING: U.S. Customs mandates that all instruments and equipment be registered, before sailing, with your local U.S. Customs Office using the U.S. Customs Form 4455.

The U.S. Customs Form 4455 is provided in this booklet.

We recommend that instruments/equipment be stored in the performer's cabin. If additional storage is necessary, a special storage cabin may be provided at an additional cost.

Assistance with instrument and luggage loading at the pier is provided by the stevedores. They are employed by the port authority and they will expect a gratuity. This gratuity is not covered under the pre-paid gratuity in your tour package. Carnival Cruise Lines or Four Seasons Tours is not responsible for lost, stolen, or damaged luggage or instruments loaded by the stevedores or stored in cabins provided.

TROPHIES & AWARDS: Each instrumental and choral group will receive a large trophy which will be presented at the festival awards ceremony. A medal with appropriate rating(s) for each event entered will be draped around the trophy. Each rating will represent the following:

SUPERIOR	90-100 points	Gold Medal
EXCELLENT	80-89 points	Silver Medal
GOOD	70-79 points	Bronze Medal
PARTICIPATION	0-69 points	No Medal

DATE & TIME: Carnival dictates the date, time and location of the festival. Rock the Boat staff makes every effort to arrange performance times on days while the ship is at sea.

PERFORMANCE REQUIREMENTS: Sound technicians will be provided for two hours for each school. This does not include set up and tear down. Additional technician time will be charged to the group at a rate of \$150.00 per hour or any part of an hour. Performers are not permitted to perform songs that include; verbal profanities, racial, ethnic, or sexual slurs, no drug or drinking related songs.

VOCAL SOLO: Soloists may perform only one composition. They may choose from any style music literature from classical to pop. Total onstage time may not exceed five minutes. No clinics or tapes are given in this category. Soloists are included in your allotted two hour festival time.

ADJUDICATORS: Rock the Boat with Festivals at Sea takes great pride in providing adjudicators of the highest caliber for our festivals. These adjudicators will provide written and taped comments, on stage workshops and scores and ratings for each performance.

LIGHTING AND SOUND EQUIPMENT: Sound equipment is provided by Carnival Cruise Lines. Sound equipment is capable of playing compact discs only, and is not capable of playing cassette tapes. A Carnival sound technician will be provided to assist with your festival performance. Only the technician is permitted to operate the sound and lighting equipment.

PERFORMANCE EQUIPMENT: An acoustic piano or electric keyboard will be available on all ships. Music stands and risers are available on the Fascination only. Music stands only, are available on the Paradise. Chairs can be provided for your performance and must be pre-arranged on your performance information form. No instruments will be provided and music stands or risers are not available on other ships.
