I understand that as the chaperone, it will be my obligation to see that the below named minors behave in a civil manner and adhere to the guidelines below during the cruise.

For the safety, security and enjoyment of all of our guests, the following rules must be followed:

1. The legal drinking age onboard is 21 and is strictly enforced. We do not permit the purchase of drinks or bottles of liquor by adults for minors. (Possession of alcohol by a minor will not be tolerated and any found will be confiscated (even if found in cabin). Please refer to the ticket contract for additional information regarding alcohol and minors.
2. Purchase, possession and consumption of drugs is illegal.
3. No abusive, offensive or vulgar language or gestures should be directed to other guests or to staff and crew.
4. Headphones must be used with radios or music players on deck.
5. No running in the hallways.
6. No noise in cabin areas or corridors.
7. Our shipboard credit program ("Sail & Sign") requires either a minimum \$100.00 or \$150.00 (based on cruise duration), cash deposit or a credit card, (American Express, Discover, Visa or MasterCard) IN THE GUEST'S OWN NAME, presented at check-in. The credit card companies prohibit use of an account other than that of the traveling guest. The guest is responsible to keep a positive cash balance at all times during the cruise. If there is an overage on the cash account, the guest is issued a check on board the morning of debarkation day with a copy of the final statement.
8. When a group has 8 or more staterooms who are not traveling with their parent, grandparent or court-appointed legal guardian, then guests in those staterooms will be required to pre-pay gratuities and those minors will be required to pay \$100 per person damage deposits due at final payment. Damage deposits will be withheld in the case of physical damage to the ship or other costs incurred as a result of inappropriate behavior. We will assess the charge against the entire group's damage deposit.

Failure to comply with these guidelines will result in the offender(s) being removed from the ship to make his or her own way home. Alternatively, the disruptive guest(s) may be confined to their stateroom for the duration of the voyage.

I hereby accept full responsibility as the escort for the minors listed above during the cruise and to ensure they follow all rules established by the ship.
